



Minutes of the Municipal Board of Canvassers (MBOC) and the Board of Canvassers
held at Greenfield City Hall, Common Council Chambers, Room 100
on Monday, April 13, 2020

The Municipal Board of Canvassers (MBOC) meeting was called to order by City Clerk Jennifer Goergen at 8:10 a.m.

Oaths were administered. Absentee ballots were processed until approximately 11:40 a.m. Recessed until approximately 12:11 p.m. and reconvened to look through all ballots for write-in votes. Absentee ballots that could not be processed for various reasons (missing the voter’s signature, missing a witness signature, missing a witness address, or post-marked after the deadline of April 7, 2020) were recorded on the Inspectors’ Statements as being rejected. Election results tapes were printed and signed and necessary paperwork completed. The MBOC concluded their work at approximately 5:45 p.m. and the meeting was adjourned.
