1. Call to order
Meeting called to order at 5:00PM
2. Roll Call

3. Pledge of Allegiance
4. Election of Commission officers
Motion by Commissioner Springob, seconded by Commissioner Brown to continue the officer positions as they are now. Motion carried on a unanimous roll call vote.
5. Approval of the Police and Fire Commission minutes from November 10, 2020
Motion by Commissioner DeGaro to adopt the minutes from the November 10, 2020 meeting with an amendment to read under Section 5(a) *"The Commission reviewed the record of the candidate for promotion to Detective."*, seconded by Commissioner Brown. Motion carried on a unanimous roll call vote.
6. Commission to go into closed session pursuant to Statute 19.85 (1) (c) (e) (f) of the Wisconsin State Statutes. Specifically: (c) Considering employment, promotion, compensation or performance evaluation data of any public employee over which the governmental body has jurisdiction or exercises responsibility, and (e) Deliberating or negotiating the purchasing of public properties, the investing of public funds, or conducting other specified public business, whenever competitive or bargaining reasons require a closed session. (f) Considering financial, medical, social or personal histories or disciplinary data of specific persons, preliminary consideration of specific personnel problems or the investigation of charges against specific persons except where par. (b) applies which, if discussed in public, would be likely to have a substantial adverse effect upon the reputation of any person referred to in such histories or data, or involved in such problems or investigations.
