

MINUTES OF THE POLICE & FIRE COMMISSION MEETING HELD AT THE GREENFIELD LAW

1. Call to order
Meeting called to order at 6:00PM
2. Roll Call
Present: Patsy Cashmore, Steve Brown, Dennis Clark, Julie DeGaro, Francis Springob

3. Pledge of Allegiance
4. Approval of the Police and Fire Commission minutes from November 18, 2020
Motion by Commissioner DeGaro, seconded by Commissioner Springob. Motion carried on a unanimous roll call vote.
5. Commission to go into closed session pursuant to Statute 19.85 (1) (c) (e) (f) of the Wisconsin State Statutes. Specifically: (c) Considering employment, promotion, compensation or performance evaluation data of any public employee over which the governmental body has jurisdiction or exercises responsibility, and (e) Deliberating or negotiating the purchasing of public properties, the investing of public funds, or conducting other specified public business, whenever competitive or bargaining reasons require a closed session. (f) Considering financial, medical, social or personal histories or disciplinary data of specific persons, preliminary consideration of specific personnel problems or the investigation of charges against specific persons except where par. (b) applies which, if discussed in public, would be likely to have a substantial adverse effect upon the reputation of any person referred to in such histories or data, or involved in such problems or investigations.

Motion by Commissioner Springob to move the interviewed candidate on to the next step of the hiring process, seconded by Commissioner Brown. Motion carried on a unanimous roll call vote.
