

MINUTES OF THE POLICE & FIRE COMMISSION MEETING HELD AT THE CONFERENCE ROOM OF THE GREENFIELD FIRE DEPARTMENT STATION #2, ON THURSDAY, JANUARY 20, 2022, AT 5:00PM

1. Call to order
Meeting called to order at 5:00PM by Commissioner Cashmore.
2. Roll Call

3. Pledge of Allegiance
4. Approval of the Police and Fire Commission minutes from November 17, 2021
Motion to approve the minutes from the November 17, 2021 meeting by Commissioner Brown, seconded by Commissioner Springob. Motion carried on a unanimous vote.
5. Discussion/Decision on update to Fire Department hiring process
Motion by Commissioner DeGaro to make a current CPAT Exam a requirement prior to a conditional offer of employment, seconded by Commissioner Springob. Motion carried on a unanimous roll call vote.
6. Commission to go into closed session pursuant to Statute 19.85 (1) (c) (e) (f) of the Wisconsin State Statutes. Specifically: (c) Considering employment, promotion, compensation or performance evaluation data of any public employee over which the governmental body has jurisdiction or exercises responsibility, and (e) Deliberating or negotiating the purchasing of public properties, the investing of public funds, or conducting other specified public business, whenever competitive or bargaining reasons require a closed session. (f) Considering financial, medical, social or personal histories or disciplinary data of specific persons, preliminary consideration of specific personnel problems or the investigation of charges against specific persons except where par. (b) applies which, if discussed in public, would be likely to have a substantial adverse effect upon the reputation of any person referred to in such histories or data, or involved in such problems or investigations.
