The House of Harley is having their 120th Anniversary event July 10-July 17, 2023.

The House of Harley is requesting full closure of W. Layton Ave. from S. 60 St. to S. 68 St. from 6:00am, Monday, July 10th until 6:00am, Monday, July 17th. A detour route and visuals/maps are attached.

Permits for special events on County highways are only issued to the municipality. In the past, the city has obtained the permit for the House of Harley.

The House of Harley pays for the permit.
