

MINUTES OF THE POLICE & FIRE COMMISSION MEETING HELD AT THE ADMINISTRATIVE CONFERENCE ROOM OF THE LAW ENFORCEMENT CENTER, ON THURSDAY, NOVEMBER 9, 2023, AT 6:00PM

1. Call to order

4. Approval of the Police and Fire Commission minutes from the September 6, 2023 and October 11, 2023 meetings

Approval of September 6, 2023 meeting minutes tabled until next meeting. Motion to approve the October 11, 2023 meeting minutes by Commissioner Brown, seconded by Commissioner DeGaro. Motion carried on a unanimous roll call vote.

5. Commission to go into closed session pursuant to Statute 19.85 (1) (c) (e) (f) of the Wisconsin State Statutes. Specifically: (c) Considering employment, promotion, compensation or performance evaluation data of any public employee over which the governmental body has jurisdiction or exercises responsibility, and (e) Deliberating or negotiating the purchasing of public properties, the investing of public funds, or conducting other specified public business, whenever competitive or bargaining reasons require a closed session. (f) Considering financial, medical, social or personal histories or disciplinary data of specific persons, preliminary consideration of specific personnel problems or the investigation of charges against specific persons except where par. (b) applies which, if discussed in public, would be likely to have a substantial adverse effect upon the reputation of any person referred to in such histories or data, or involved in such problems or investigations.
