

MINUTES OF THE MEETING OF THE CITY OF GREENFIELD BOARD OF CANVASSERS HELD AT THE GREENFIELD CITY HALL ON MONDAY, APRIL 7, 2025

The City Clerk and two citizens of the City of Greenfield, appointed by the City Clerk, met as the Board of Canvassers at the Greenfield City Hall on Monday, April 7, 2025. The purpose of the meeting was to canvass the votes cast in the Spring Election and to declare the results thereof in accordance with Section 7.53 of the Wisconsin Statutes.

The meeting was called to order by City Clerk Jennifer Goergen at 9:00 a.m.

The City Clerk reported that two provisional ballots were issued at the polls; one in Ward 3 and one in Ward 8. The provisional ballots could not be counted because the voters did not provide the information required by 4:00 p.m. on Friday, April 4, 2025 in order to have their ballots counted.

The City Clerk reported that a Ward 8 ballot was placed on the table behind the DS200 voting machines on Election Day that had not been counted and should have been. The Chief Inspector had closed the polls and turned off the DS200 voting machine when the election workers noticed the Ward 8 ballot had not been processed through the DS200 voting machine. They logged this incident on the Ward 8 Inspectors' Statement. The Board of Canvassers accepted this ballot and tallied the votes for Ward 8. (Amended Ward 8 results follow.)

We, the City Clerk and two citizens appointed by the City Clerk, Devan Gracyalny and Denise Collins, certify that we are the members of the Board of Canvassers for the City of Greenfield, Milwaukee County.
