Motion by Commissioner Springob, Seconded by Commissioner DeGaro with unanimous decision on a roll call vote for the Commission to go into closed session pursuant to Statute 19.85 (1) (c) (e) (f) of the Wisconsin State Statutes. Specifically: (c) <u>Considering employment</u>, promotion, compensation or performance evaluation data of any public employee <u>over which the governmental body has jurisdiction or exercises responsibility</u>, and (e) <u>Deliberating or negotiating</u> the purchasing of public properties, the investing of public funds, or conducting other specified public business, <u>whenever competitive or bargaining reasons require a closed session</u>. (f) <u>Considering financial, medical, social or personal histories</u> or disciplinary data <u>of specific persons</u>, preliminary consideration of specific personnel problems or the investigation of charges against specific persons except where par. (b) applies which, if discussed in public, would be likely to have a substantial adverse effect upon the reputation of any person referred to in such histories or data, or involved in such problems or investigations.
